WHEREAS, Born in Oregon Corners in Putnam County, New York, Helen Gordon was a Prudential Insurance Agent for many years, as well as a teacher in the Ballston Spa School District where she worked with students with special needs; and

WHEREAS, Helen Gordon, a devoted wife and mother of six children, gave tirelessly of her time and energies, volunteering countless hours to the Jewish Community Center of Saratoga Springs to ensure members of the congregation enjoyed social gatherings in addition to the religious services; and

WHEREAS, Sid and Helen Gordon have been married for more than 40 years and enjoyed running their own vending machine business together for 25 years; and

WHEREAS, It has always been the objective of this Legislative Body to honor and support those individuals who have displayed their

commitment to the betterment of their communities, and it is the intent of this Legislative Body to inscribe upon its records, this tribute to Sid and Helen Gordon, so that future generations may know and appreciate

their admirable characters, their many benevolent deeds, and the respect and esteem in which they are held; now, therefore, be it
