WHEREAS, Since the merger of Avoca and Prattsburgh's boys basketball teams in 2020, the Titans are 62-2 with three straight Section V Class D titles; in 1999, Avoca High School beat Prattsburgh High School in the Section V Class D state qualifier, which was Avoca's first section championship in 20 years, and Prattsburgh's D2 crown was its third section title since 2015; and
