Senator Pam Helming was joined today by Tom Wahl Sr. and members of the Wahl family to celebrate the selection of Tom Wahl's Avon for the New York State Historic Business Preservation Registry. The state program highlights businesses that have been in operation for at least 50 years and have contributed to their community's history, heritage, and identity.

Founder Tom Wahl Sr. opened the original Tom Wahl's restaurant on March 19, 1955, on Routes 5&20 in Avon, Livingston County. Wahl went on to create a unique chain of fast-food restaurants in the Finger Lakes region. In 1986, Wahl sold his restaurants to Bill Gray's Inc.

**Senator Helming** said, "Tom Wahl's Avon is a local treasure for so many families in our region and a symbol of pride for the residents of Avon and Livingston County. The New York State Historic Business Preservation Registry ensures that we recognize those businesses with a longstanding investment in the economic vitality and quality of life in our communities. I thank Mr. Wahl for his spirit of entrepreneurship that has truly made a difference in Avon and the Finger Lakes, for people of all ages, particularly the many young people employed at Tom Wahl's restaurants. **Tom Wahl Sr.** said, "Hundreds of young people worked their way through college at this restaurant, and I remain proud of the business I started so many years ago.
