WHEREAS, Prior to her finals match, Mia Collins recorded a 38-second pin in her first match; in her quarterfinal, she secured a reversal with 17 seconds remaining to win a 6-4 decision, and then put together a second-period pin in the semifinals; and

WHEREAS, Earlier in the month of January 2024, Mia Collins captured the Eastern States Classic title at 132 pounds with a 7-0 championship decision over Jaida Macaluso of Minisink Valley; and

WHEREAS, The athletic talent displayed by this scholar athlete is due in great part to the efforts of a great team of coaches, skilled and inspirational tutors, respected for their ability to develop potential into excellence; and

WHEREAS, In a sport such as wrestling, which demands athletic prowess, speed and agility, Head Coach Jacob Warren, and Assistant Coach Colby Harblin worked hard to hone the skills of this champion, teaching this outstanding athlete lessons which will prove invaluable both on and off the mat; and
