DeWolf was a silent force for good, consistently helping others without seeking recognition; he demonstrated this generous spirit as a 32-year member of the Fairville Fire Department, where his contributions were immeasurable, earning him the prestigious Fireman of the Year Award multiple times; he tirelessly undertook various tasks for the department during his long and impactful tenure; and
