WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Ron Scott has displayed throughout his life; and

WHEREAS, In the performance of his duties, Ron Scott has demonstrated his character and his compassion for the welfare of others; he is a tremendous asset to his EMS Unit and a distinguished citizen of the State and Nation; and
