Fountain's role in transitioning Cazenovia College into a State Police Basic Training Program was indispensable; and

WHEREAS, Despite a challenging time frame, Lieutenant Steven P.
Fountain effectively managed numerous tasks, including personnel selection, building maintenance, coordination with property management, facility cleaning, internet and phone system installation, school/community outreach, as well as policy development, all within 55 working days; and

WHEREAS, Lieutenant Steven P. Fountain's creative input was invaluable as he transformed the campus into a State Police facility

adorned with memorabilia reflecting the rich history of the New York State Police, and memorializing its fallen members; and

WHEREAS, Furthermore, his energy, positive attitude, interpersonal
