WHEREAS, From 1971 to 1985, Richard Marley went to work at Mohawk Valley Community College as an auditor in the Business Office and the head of Office Services; he then moved to Clinton in 1982, shortly before his retirement in 1985; and

WHEREAS, With him throughout have been his partner, Mary Jane Presite, three children, five grandchildren, and two great-grandchildren, all of whom feel privileged to be a part of his life and rejoice in his achievements; and

WHEREAS, At age 55, Richard Marley began golfing and skiing, and he has been a member of the Oneida Golf Club for nearly 23 years; and

WHEREAS, Richard Marley, with his zest for life, has inspired and enhanced the lives of his family and friends; and

WHEREAS, This exceptional centenarian has experienced the incredible joys and sorrows characteristic of and reserved for those with the stamina and courage to savor a full life; and
