WHEREAS, Attendant to such concern, and in full accord with its long-standing traditions, this Legislative Body is justly proud to honor Kenmore Mercy Hospital upon the occasion of receiving the 2023 Leapfrog Top Hospital Award for Outstanding Quality and Patient Safety; and

WHEREAS, The Leapfrog Group is a national industry watchdog organization of employers and other large purchasers of health care known for setting the toughest quality standards; the Leapfrog Top Hospital Award is widely acknowledged as one of the most competitive awards and American hospital can receive; and

WHEREAS, To qualify for this distinction, hospitals must rank top among peers on the Leapfrog Hospital Survey, an assessment of hospital performance centered on the highest standards for quality and patient safety; and

WHEREAS, Of more than 2,100 hospitals considered for this esteemed accolade, only 35 general hospitals were successful in receiving the coveted award; Kenmore Mercy Hospital was one such hospital of the 35 in the nation, and was the only hospital in New York State to be designated for this recognition; and

WHEREAS, Along with this momentous designation, Kenmore Mercy Hospital received its twentieth consecutive "A" Safety Grade, making it one of only 36 hospitals in the country, and the only one in New York with this distinction; and

WHEREAS, Proving patient safety to be the utmost priority time and time again, Kenmore Mercy Hospital is justly deserving of this 2023 Leapfrog Top Hospital Award for Outstanding Quality and Patient Safety, and merits the applause of all citizens of this great State and Nation; and
