WHEREAS, Sheriff Errol D. Toulon Jr.'s approach to law enforcement focuses on the power of community input in government, volunteerism behind the bars, and how correctional institutions can change lives for the better; revisioning the role of the Sheriff's Office literally starts with him, as he has been a steward of the Sheriff's Transition and Reentry Team (S.T.A.R.T.) which began under his leadership; and
