WHEREAS, A man of singular distinction, Enzo Pizzimenti has continually demonstrated extreme competence, extraordinary intelligence and diligent leadership in his unwavering service to his community and profession and consequently has been designated for this most prestigious honor; and

WHEREAS, Enzo Pizzimenti owns and operates several companies in diverse business sectors; the experience he acquired while working with READER'S DIGEST proved useful in establishing his first company, C. Pizzimenti started to direct his attention to the international business arena; he founded the Italian Center for Commercial Affairs in Rye Brook, New York, an organization committed to promoting commercial, industrial and cultural exchange between Italy and Westchester County; and

WHEREAS, Enzo Pizzimenti's contacts within the international business community led him to sponsor and support many events in conjunction with the European Union association related to international banking and renewable energy; to that end, he has recently initiated the International Center for Commercial Affairs (ICCA), in an effort to promote and develop activities that in keeping with the times, will promote and develop sustainable technology on an international level; and

WHEREAS, Enzo Pizzimenti has been called upon to contribute his time and talents to countless civic and charitable endeavors and has always given of himself unstintingly; and
