WHEREAS, From 1957-1979, Pauline Crombe taught 3rd, 4th, and 5th grades as well as Remedial Reading in the Webster School District; and

WHEREAS, Pauline Crombe has been called upon to contribute her time and talents to countless civic and charitable endeavors and has always given of herself unstintingly; and

WHEREAS, A valued and involved member of her community, Pauline Crombe has significantly contributed to the preservation of the cultural heritage of the Town of Ontario; this has been demonstrated by her many hours of volunteer work as administrative support, and her many hours of labor she contributed in maintaining Heritage Square Museum; and

WHEREAS, Pauline Crombe has offered her support to the growth of Heritage Square Museum by: serving as Secretary of the Town of Ontario Historical and Landmark Preservation Society for many years; physically mowing the lawn and painting the buildings at the site; organizing and working fundraising events such as "Polly's Pie Sales" which have benefited the Historical Society; and making personal financial contributions which supported the addition of several buildings to Heritage Square Museum; and

WHEREAS, Throughout the entire period of her community service, a period of constructive involvement, Pauline Crombe has stood constant in dignity, good grace and humor; and
