WHEREAS, This Legislative Body is justly proud to commemorate the 21st Annual National Jewish Sports Hall of Fame and Museum Induction Ceremony to be held at the Suffolk Y Jewish Community Center in Commack, New York, on Sunday, April 21, 2013; and

tics; Marilyn Ramenofsky, swimming; and Garrett Weber-Gale, swimming;

WHEREAS, In addition, Boyd Melson, boxer, will be the recipient of The Dick Steinberg Good Guy Award; and James Metzger, Chairman and CEO, The Whitmore Group, will receive The George Young Award; and

WHEREAS, The careers of the inductees of the National Jewish Sports Hall of Fame and Museum provide a legacy of commitment and excellence, bringing them distinction and serving as inspiring models for all who aspire to growth and success; and

WHEREAS, It is the sense of this Legislative Body that when individuals of such noble aims and accomplishments are brought to our attention, they should be celebrated and recognized by all the citizens of this great Empire State; now, therefore, be it
