WHEREAS, Anthony Iovino has been called upon to contribute his time and talents to countless civic and charitable endeavors in Oceanside and has always given of himself unstintingly; and

WHEREAS, For several years he was president of Kiwanis, and he served as a member of the school board from 1994 to 1997; he is currently the Oceanside Library's special projects coordinator where he has developed an email list and set up the library's Facebook page, opening up the library to new users; and
