"Joey" Nicosia has been a member of Ducks Unlimited for 28 years; in that time he has graciously assumed the mantle of leadership in many capacities, serving as Area Chairman, District Chairman, and State Vice Chairman, and lending his talents to the Marketing and Communications Committee; and

WHEREAS, Joseph "Joey" Nicosia, in addition to his current role as State Chairman, serves on the State Campaign Committee, the Development Committee and the Friends of Montezuma Board; within Ducks Unlimited, he is a Diamond Heritage Sponsor for Ducks Unlimited Inc., a Canada Diamond

Life Sponsor, and a Mexico Diamond Life Sponsor; and

WHEREAS, During his illustrious two-year term as State Chairman, Joseph "Joey" Nicosia has been an active advocate of the organization's Greenwing program, a youth program that teaches its young members the importance of responsible hunting and the importance of conservation; and
