WHEREAS, in 1995, Dr. Marie Bernard established The Work of Salvation Ministries in Queens Village, New York, and is dedicated to reaching and changing lives within her community; she also provides leadership to the ministry chaplaincy Christian board, and is actively involved with the homeless food pantry outreach evangelism home prayer and street ministry throughout the United States and foreign countries; and
