opportunities for artistic expression and teen development through
music, marching, dance, and entertainment; several members of the band
are students at St. Christopher's School; and

WHEREAS, The Marching Cobras of New York has distinguished itself in its many impressive accomplishments; successes include: being named 1st Place Grand Champions in the 2013 New York City State Championships; taking 1st place in both the New York Salute to Israel Parade and the "Cakeman Parade" in Brooklyn; and being awarded the Pace University Drum-Line Contract; and
