WHEREAS, With a kitchen upgrade, a dining room refresh and a menu update, Mike Cioffi gave the Phoenicia Diner a fresh new look while keeping the old charm of bygone days when a diner meant a welcome environment, great food and a respite from travel; and

WHEREAS, By offering residents, weekenders and visitors fresh food sourced from the Catskills and Hudson Valley farms, a menu crafted by his chef Mel Rosas, offering traditional diner favorites, some with a modern twist, the Phoenicia Diner has become the hottest spot to eat along the Route 28 roadway; and

WHEREAS, This Legislative Body is proud to recognize Mike Cioffi, owner of the Phoenicia Diner, for his commitment and contributions to the central Catskills area and to its quality of life; and
