state; and

WHEREAS, A few years later, Gloria Smyth-Godinger was again tapped to take on the role of clerk-in-charge of the court's Trial Support Office, which oversees case management-related functions; she worked diligently to promote best case management practices, and ensure adherence to time tables for resolving cases; and

WHEREAS, Dedicated to the enhancement of her profession, Gloria Smyth-Godinger also helped organize a neutral evaluation program to promote out-of-court settlements in personal injury and other matters, among other innovations; and

WHEREAS, Today, Gloria Smyth-Godinger is renowned for her amazing work stamina, and can-do attitude, as well as her institutional knowledge, and mastery of the many automated systems introduced by the court system in recent years; and

WHEREAS, This legendary public servant is widely regarded for her efforts as a mentor to both the court employees and countless high school, college, and law students who have interned at the New York State County Supreme Court over the years; and

WHEREAS, A singular asset to all of the citizens she has served in the State of New York, Gloria Smyth-Godinger's life and career are a portrait of preeminence in public service and serve as a role model for all who aspire to a career in public service; and
