WHEREAS, At age 18, Aileen McKinnon was baptized at the John Street Church of God; she worked at a tobacco company which was one of the largest companies in Guyana; she was employed there as a clerk typist and worked there until her migration to the United States on August 6, 1969; and

WHEREAS, Aileen McKinnon enrolled in Brooklyn College where she studied interior design; in the 1970s, she joined God's Battalion of Prayer Church and worked as a filing clerk at Ideal Corporations; and WHEREAS, Active in her community, two years ago Aileen McKinnon began to serve at God's Battalion of Prayer Church soup kitchen and counseled men and women from different shelters every fourth Saturday of each month; in addition, she serves at the JASA Institute for Senior Action; and

WHEREAS, It is the sense of this Legislative Body that those who enhance the well-being and vitality of their community and have shown a long and sustained commitment to excellence certainly have earned the recognition and applause of all the citizens of this great Empire State; now, therefore, be it
