WHEREAS, Services Now for Adult Persons, Inc. numerous homebound programs and services include: case management, transportation to medical services, senior centers, and shopping facilities, home delivered meals, obtaining benefits and entitlements, information and referral, advocacy, and volunteer services; and

WHEREAS, In addition, Services Now for Adult Persons, Inc. runs a very successful Caregiver Program to assist caregivers in the task of caring for elderly loved ones; its services include counseling, support groups, educational seminars, information assistance, referrals, and respite services; and

WHEREAS, Services Now for Adult Persons, Inc. works closely with all the not-for-profits in the aging network and with all service providers in its community; these relationships have proven to be helpful in understanding and negotiating the social service system for their clients; and
