WHEREAS, Furthermore, CJ Theiss has reached out to GLSEN for support and inclusive curriculum to help educate the Shaker Junior High School community; she has since become a resource herself and has helped other local educators in supporting youth within schools in other districts; and

WHEREAS, CJ Theiss has clearly had an enduring impact on the youth of Shaker Junior High School, as well as on the community-at-large, and accordingly merits recognition and applause for her impressive dedication to others; and

WHEREAS, It is the sense of this Legislative Body that when individuals of such noble aims and accomplishments are brought to our attention, they should be celebrated by all the citizens of this great Empire State; now, therefore, be it
