Title; and

WHEREAS, Three exceptional players, Scott Albright, Kevin Berry, and Scott Wojans, were chosen for both the All-Tourney Team in Glens Falls, as well as three different All-State teams; and

WHEREAS, The hallmarks of the 1982 New York Mills Boys Varsity Basket-ball Team, from the opening game of the season to participation in the championship, were a brotherhood of athletic ability, of good sportsmanship, of honor and of scholarship, demonstrating that these team players were truly second to none; and
