WHEREAS, Judge Josephine Finn has been the proud recipient of countless awards and accolades some of which include the Frederick Douglass Award from the Association for the Study of Afro-American Life and History, the Sullivan County Chamber of Commerce Community Service Award, the Business and Professional Women's Community Service Awards, as well as the Every Day Hero Award from Kiwanis International, Monticello chapter; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Judge Josephine Finn has displayed throughout her life; and

WHEREAS, It is the practice of this Legislative Body that those who enhance the well-being and vitality of their community and have shown a long and sustained commitment to excellence certainly have earned the recognition and applause of all the citizens of this great Empire State; now, therefore, be it
