LEGISLATIVE RESOLUTION honoring Detective Nicholas Abrams for his generous contributions in refurbishing Pocket Park located in the West Hill Neighborhood of Albany, New York

WHEREAS, For the past 13 years, Nicholas Abrams has served the Albany Police Department with honor and distinction; and

WHEREAS, A graduate from the Zone Five Regional Law Enforcement Training Center in 2001, Nicholas Abrams was first assigned to the North Station serving as Patrol Officer; in 2010, he was assigned to the Neighborhood Engagement Unit where he served as a beat officer in the West Hill Neighborhood of Albany; and

WHEREAS, During his three years in the Neighborhood Engagement Unit, Detective Nicholas Abrams built strong ties with the community by organizing bike rodeos, working side by side with several community leaders, and becoming a certified Gang Resistance Education and Training instructor; and
