WHEREAS, Adirondack Tri-County Nursing and Rehabilitation Center offers a chance for the home bound elderly to get out of their homes and join others who need special care in a friendly and safe environment; their Adult Day Care Center is located in the nursing home in North Creek, and is the only service of its kind offered in the South Central Adirondacks; and

WHEREAS, With the only Outpatient Therapy Services in the area, Adirondack Tri-County Nursing and Rehabilitation Center provides its patients with Therapists who are well trained and have extensive experience in many areas of therapy; and

WHEREAS, The Activity Department at Adirondack Tri-County Nursing and Rehabilitation Center is focused on providing group and individual activity opportunities for its residents; the goal of activity programming is to enhance the residents' highest practicable level of physical, mental and psychosocial well-being; and

WHEREAS, Furthermore, community outings to local restaurants and for shopping or picnics are held each month where many of the facility's residents are given the opportunity to enjoy the surroundings of the beautiful Adirondacks; and

WHEREAS, This significant milestone is an excellent opportunity to recognize the special contributions of Adirondack Tri-County Nursing and Rehabilitation Center and the dedicated individuals who strive to better the quality of life for senior citizens in the community; and
