WHEREAS, She then went on to serve as both President and Chief Executive Officer (CEO) of the Family Planning Advocates of New York State (FPA); she led this statewide coalition representing more than 125 civic, labor, religious, health, and human service agencies promoting access to and affordability of comprehensive reproductive health care services for women and families statewide; and

WHEREAS, As President and CEO of Planned Parenthood Advocates of New York, M. Tracey Brooks was responsible for directing the political and advocacy arm of Planned Parenthood; and

WHEREAS, Throughout her career, M. Tracey Brooks served Family Planning Advocates of New York State and Planned Parenthood Advocates of New York with intelligence and caring dedication, continuously striving to effectively fulfill the duties of her position; and
