WHEREAS, In February of 2015, Kenyette Curry collaborated with the National Heart Association to spotlight her center for one of their Healthy Heart kick-off initiatives; and

WHEREAS, Furthermore, Kenyette Curry was a leader of Head Start's new safety committee, where she was instrumental in helping create new initiatives to increase safety procedures and best practices; her leadership fostered an agency atmosphere where safety is number one; and

WHEREAS, Active in her community as well as her profession, Kenyette Curry is a member of various agency committees, task force groups, and program planning groups; and

WHEREAS, Kenyette Curry has clearly had an enduring impact on the youth of the CEO Head Start, as well as on the community-at-large, and accordingly merits recognition and applause for her impressive dedication to others; and
