WHEREAS, In addition, FAACSO strives for the elevation of the socio-e-conomic level of civil service employees; furthermore, it supports the plans of action of its member organizations and supports their designated candidates for positions on policy-making levels; and WHEREAS, FAACSO has provided outstanding service handling the numerous complaints of racial discrimination it receives annually; it has been instrumental in gaining justice for countless civil service employees who have received unfair treatment; and


