WHEREAS, Moreover, Betty Davis brings blankets and bonnets to new mothers in the maternity ward at the local hospital, and collects gifts and other items for veterans at the VA Hospital in Syracuse, New York; and

WHEREAS, Betty Davis serves as Treasurer of the Lowville Senior Club, and organizes many dinners at the VFW for public dances and funerals; she also works at fundraising events for auxiliary functions, and helps obtain items and wrap presents for servicemen during the Christmas season; and

WHEREAS, This remarkable woman was the recipient of the Randy Streeter Senior Citizens of the Year Award for her outstanding philanthropic works and positive attitude; and

WHEREAS, Throughout the entire period of her community service, a period of constructive involvement, Betty Davis has stood constant in dignity, good grace and humor; and
