Oppenheimer chairs the Westchester Senate delegation, which includes Senators Ruth Hassell-Thompson, Jeff Klein, Vincent Leibell, and Andrea Stewart-Cousins.

**The hearing will be held on Friday, March 19, 2010, from 9:30 a.m. to 12:30 p.m. at the Greenburgh Town Hall, 177 Hillside Avenue, Greenburgh, NY.**
