Senate members from both sides of the aisle chose this year's nominees for their dedication to community and their achievements in education, the arts, health, and business. The women selected have not only achieved great success on an individual level, but on a social level as well, strengthening our state and making it a better place.

Senator Ruth Hassell-Thompson (D-Mt. Vernon) said, "It is with great pleasure that I join with my colleagues to recognize these remarkable women who represent the very best of what New York State has to offer. As leading members of our communities, role models and entrepreneurs, these women have devoted themselves to improving the world for others, and for that, they should be honored and thanked."

Senator Liz Krueger (D-Manhattan) said, "I am proud and honored to be a part of the celebration that recognizes the excellence of these amazing women. The strength of these women can be found in the countless lives they have touched and the organizations they have enriched.
