Senator Carlucci Passes ABLE Act

Senator David Carlucci has passed S4472D/A7767B, legislation that will provide people with disabilities and their families the opportunity to create a tax-exempt savings account that can be used for maintaining health, independence and quality of life.

In December 2014, the Federal Government passed the Achieving a Better Life Experience also known as the ABLE Act. This legislation, allows family members or caregivers to save money for a loved one that has a disability, tax free. Now that New York has passed S4472D, they can take part in this historic program.

Millions of individuals with disabilities and their families depend on a wide variety of public benefits for income, health care and food and housing assistance. Historically, the eligibility for these public benefits has required people with disabilities to be financially insolvent, denying them the opportunity to plan for the future. For the first time in public policy, the ABLE Act recognizes the extra and significant costs of living with a disability.

“This legislation provides us with a real opportunity to make a difference in the lives of people with disabilities,” said Senator Carlucci. “Passing this important legislation gives our friends, neighbors and family members with disabilities throughout this state deserve a better, brighter and more secure future.”

“On behalf of our Board and CEO Jill Warner and all of us at Jawonio, we are delighted that both the Senate and Assembly passed the ABLE Act in support of providing choice and another pathway to independence.” Said Diana Hess, Chief Communications Officer for Jawonio. “This act will now give NYS the ability to mirror the federal guidelines and give people with special needs choices in their financial lives that will create opportunities to live their lives as independently as possible.”
