## PROPERTY TAX EXEMPTION INFORMATION

| ISSUE: **STAR (SCHOOL TAX RELIEF PROGRAM)**

There are a number of different programs available to Nassau and Suffolk County residents to help them save money on their property taxes.

### **STAR Program:**

New York State's School Tax Relief (STAR) program provides recipients with savings on their school property taxes.

The STAR program works in two parts:

**Basic STAR** is available to New Yorkers who own and live in their own home, condominium, or cooperative apartment, with an adjusted gross income that does not exceed \$500,000, regardless of age.

**Enhanced STAR** is available to senior citizen (ages 65 and older) property owners whose annual adjusted gross income level (less any IRA distributions) is under \$81,900. If the property is owned by a husband and wife, only one of them must be at least 65 years old to qualify for this exemption.
