The City will be providing bus service from these developments to the nearest shelter, beginning at 3PM and ending at 9PM. The departure point for each development is included in the attached

Please note that elevator service, heat & hot water will begin to shut off at 7PM at these developments. It is imperative that residents of these buildings leave either through public transportation or the bus service that the City is providing as soon as possible.
