WHEREAS, A Brooklyn-born native, Dayna Scarso grew up with a love and talent for dance, performing commercially, off-Broadway and with MTV at their national studios; she graduated from NYU with a Bachelor's degree in Business Administration and Photography, and began her illustrious career as head of the human resource department for Century 21 Department Stores, where she spent 15 years; and

WHEREAS, Dayna Scarso is currently a full-time wife, mother, sister and friend, and serves as class mom within her son's schools; and

WHEREAS, Throughout the entire period of their community service, a period of constructive involvement, Manni and Dayna Scarso have stood constant in dignity, good grace and humor; and
