WHEREAS, Since the early days of "teapot steamers," the volunteer firefighter has been the cornerstone of our great Nation's efforts to spare us from the ravages of fire; and

WHEREAS, This Legislative Body is proud to commend Firefighter Eugene A. Preston upon the occasion of his designation for special recognition after 55 years of dedicated service to the North Greece Fire Department; and

WHEREAS, A longtime member of the Society for Preservation and Appreciation of Motorized Fire Apparatus in America, Eugene A. Preston is a

member of numerous firematic organizations some of which include:

national Association of Fire Chiefs, and Firemen's Association of the  
State of New York; and

years prior to her passing in 2008; and
