WHEREAS, For eight years, Trina S. Newton taught seventh and eighth
grade Science in the Jamestown City School District, later becoming a
Staff Development Specialist and Coordinator of the School Improvement
Program at the Erie 2-Chautauqua-Cattaraugus BOCES; and
WHEREAS, Trina S. Newton moved to Ithaca, New York, where she served
as Director of School Improvement Services for the Tompkins-Seneca-Tioga
BOCES; additionally, she was an Adjunct Professor in the Department of
Education at the SUNY College at Fredonia; and
WHEREAS, Currently, Trina S. Newton supervises all K-12 curriculum and
instructional programs and the development and implementation of the
District's strategic plan, ensuring alignment with the New York State
Standards and leading support teams to improving student achievement;

WHEREAS, In addition, Trina S. Newton oversees the development and administration of grant funds, coordinates the District's Contract for Excellence plan, and chairs committees responsible for student performance, Academic Intervention Services, professional development and annual professional reviews; and

WHEREAS, An active contributor to her community, Trina S.
