WHEREAS, Attendant to such concern, and in full accord with its longstanding traditions, this Legislative Body is justly proud to honor Timothy A. Paslow posthumously upon the occasion of his designation for special recognition by Rensselaer County at its Honor-A-Deceased-Veteran Ceremony on Monday, July 11, 2016; and

WHEREAS, For his courageous and dedicated service to his country, Timothy A. Paslow will be recognized at this year's July Honor-A-Deceased-Veteran Ceremony; and

WHEREAS, Timothy A. Paslow, who died in 1964, at the age of 42, served his country with honor and distinction from June 4, 1943 through February 3, 1946, as a member of the United States Military during the Second World War; and

WHEREAS, A Private in the General Officers branch of the Selectees, Timothy A. Paslow was awarded the Good Conduct Medal, American Campaign Medal and the World War II Victory Medal; and

WHEREAS, A lifelong resident of Troy, New York, Timothy A. Paslow worked for Quality Assurance and the Watervliet Arsenal; and

WHEREAS, Active within his community, Timothy A. Paslow was a member

of Toastmasters and St. Nicholas Veteran's Club; and

WHEREAS, Residents of this great State must never forget the courage with which these men and women served their country, and must recognize that no greater debt is owed than that owed to those who gave their lives for their beloved Nation and to those who continue to be missing in action; and

WHEREAS, Having exhibited their patriotism both at home and abroad, these men and women demonstrated their love for their country and merit forevermore, the highest respect of their State and Nation; and

WHEREAS, Our Nation's veterans deserve to be recognized, commended and thanked by the people of the State of New York for their service and for their dedication to their communities, their State and their Nation;

now, therefore, be it
