WHEREAS, While serving with the NYPD, Henry Pelayo, Jr. was assigned

to Stevenson High School where he combined his educational experience with his desire to help young men and women make the right choices in life; and

WHEREAS, In 1976, Henry Pelayo, Jr. further displayed his passion for helping today's youth by becoming a volunteer with the Castle Hill Little League; over the years, he has served in numerous vital roles, including Coach, Manager, Senior Commissioner, and President; and

WHEREAS, During his illustrious 17-year tenure as President, Henry Pelayo, Jr.'s inspired leadership has helped increase attendance each year and created numerous success stories at the Castle Hill Little League; and
