curriculum for the organization's first Kindergarten program, and in the creation of a lending library for three, four and five year-olds; she also currently runs the QualityStars program, developing curriculum with the teachers and serving as the Judaic specialist; and

WHEREAS, In addition, Phyllis Frisch established the Center's Birthday Bag program, in which donated items are collected and put together into birthday bags for homeless children who otherwise may not celebrate their birthdays; the bags are given to the Albany food pantries and distributed to sites in the Albany area; and

WHEREAS, With a steadfast and unwavering dedication to the Sidney Albert Albany JCC, Phyllis Frisch is always thinking of ways she can help improve programming, support teachers, and assist members; her love and enthusiasm for the Center is truly evident each and every day in all that she does; and

WHEREAS, With her throughout have been her husband of 37 years, Steven, and her two sons, Adam (Stephanie) and Jared (Hanna), as well as her granddaughter, Leena, all of whom feel privileged to be a part of her life and rejoice in her achievements; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Phyllis Frisch has displayed throughout her life; and
