WHEREAS, Today, Jay and Tricia Casey Bana raise heifers for Jay's father, steers for beef, and Jersey bulls for breeding; in addition, the original farm cropland is used to grow hay and corn to feed the cattle, as well as vegetables, oats, and Christmas trees; and

WHEREAS, This esteemed couple has been called upon to contribute their time and talents to countless civic and charitable endeavors and have always given of themselves unstintingly; and
