WHEREAS, As Director of the budget and previously as the division's first Deputy Director, Mary Beth Labate was responsible for the overall development and management of the State's fiscal plan, including overseeing the preparation of budget recommendations for all state agencies

and programs, economic and revenue forecasting, tax policy, fiscal planning, capital financing, and management of the state's debt portfolio;

WHEREAS, In addition, Mary Beth Labate was responsible for overseeing budget negotiations which led to five on time budgets; and

WHEREAS, With more than 25 years of fiscal and public policy experience, Mary Beth Labate has also held leadership positions at the New York State Office of Parks & Recreation and Historic Preservation, and the New York State Division of Housing & Community Renewal; and

WHEREAS, Mary Beth Labate holds a Bachelor of Arts degree from the University of Notre Dame and a Master's of Public Administration from Rockefeller College of Public Affairs & Policy; she began her illustrious career in public service as a public management fellow; and

WHEREAS, It is the sense of this Legislative Body that those who enhance the quality of life in their community and have shown a long and sustained commitment to the maintenance of high standards in their profession, certainly have earned the recognition and applause of all the citizens of this great Empire State; now, therefore, be it
