Young Methadone Maintenance Treatment Program located in Albany, New York; he has spent the majority of his illustrious career working in human services and supporting programs that service populations at risk; and

WHEREAS, With a steadfast and unwavering commitment to social advocacy and activism, Barry D. Walston serves as President of the Albany Affiliate Black Child Development Institute, and President of Literacy New York of the Greater Capital Region; he is also the Grants Chair of the Albany Fund for Education; and

WHEREAS, Furthermore, Barry D. Walston is passionate about youth development and gives of his time and energy to local mentoring programs where he supports youth of color within the Albany City School District to reach their fullest potential; and

WHEREAS, Our society is greatly benefited by the purposeful efforts of individuals who unite for the cause of improving the quality of life for others, and who proactively work toward the goal of dignity for all; now, therefore, be it
