WHEREAS, Located in downtown Ithaca, Cinemapolis is a community cultural institution where the art of film is used to enrich people's lives, grapple with and illuminate contemporary issues, and, of course, to entertain; and

WHEREAS, Under the luminous leadership of Executive Director Brett Bossard, Cinemapolis is currently celebrating its 30th year in Ithaca; not just a theater that shows independent and art films, Cinemapolis, has become a community hub, providing opportunities for many non-profit organizations to show films relevant to their mission, hold discussions, and raise funds; and
