WHEREAS, Tanya Duhaney began her field training with the NYPD in 2001; the following year, she began her career as an officer with the 104th Precinct, patrolling the streets of her assigned sector; and

WHEREAS, One year later, Tanya Duhaney began to patrol the streets of her hometown with the 113th Precinct; after six years, she transferred to the NYPD School Unit where she worked directly with

students in several of the Southeast Queens schools; and

WHEREAS, After six years of service as a School Unit officer, Tanya Duhaney was asked to join the Community Affairs Department, where she has held the esteemed rank of Detective; in this capacity, she has been instrumental in bringing back community policing which has instilled a sense of trust between the citizens of the 113th Precinct and the police; and

WHEREAS, It is the sense of this Legislative Body that those dedicated public servants who unselfishly devote their lives to the preservation of order and the protection of others are worthy and due full praise for their commitment and noble endeavors; now, therefore, be it
