WHEREAS, Decorated with classic Asian-American decor, using bamboo, Chinese panels, and various Asian antiques, The Hollow Bistro & Brew is a popular spot for locals and travelers looking for a unique place to eat quality food; and

WHEREAS, Under the direction of General Manager, Katie Yu, a new dining room, patio and private room were built to accommodate larger groups and events in May of 2016; and

WHEREAS, The remarkable success of The Hollow Bistro & Brew is due in large part to the efforts of the Yu family, whose warmth and hospitality are easily recognized by their loyal patrons; this dynamic family is well-versed in customer service and truly makes everyone who walks through their door feel like family; and

WHEREAS, It is with great pleasure that this Legislative Body acknowledges this exceptional business and its contributions to the local and State economies, fully confident that it will continue to enjoy the sparkling successes it has experienced thus far; now, therefore, be it
