WHEREAS, In this capacity, Maureen L. Fecio furthered her education and obtained certification as a nationally recognized Childbirth Educational Specialist, international board certified Lactation Consultant, and a New York State certified HIV/AIDS Counselor; and

WHEREAS, For her dedication and professionalism, Maureen L. Fecio has received numerous awards and accolades including Mount Mercy Academy's first Catherine McAuley Distinguished Alumnae Award, Trocaire College's Distinguished Alumni Award, the Mercy Hospital's CARE Award and the Employee of the Year Award, and was named a South Buffalonian by the South Buffalo News; and

WHEREAS, Throughout her career, Maureen L. Fecio has been a vital and lifelong member of many organizations such as the Daughters of Erin, the Ladies of Kincora, the GAAA and the Town of Tonawanda Irish American Club; and
