coveted by families on Long Island; and

WHEREAS, Dr. Edward K. Melnick also established North Shore Central School District's first foundation which was created to raise funds to promote and enhance the district's educational programs; and

WHEREAS, Academically, Dr. Edward K. Melnick has brought the North Shore Central School District to its apex as one of the best educational institutions on Long Island; he is a true visionary who is always thinking about how best to prepare his students for success in an ever-changing world; and
