WHEREAS, Dr. Chhaya Patel has also had a profound impact on Woodhull Hospital's General Pediatrics residency training program; her role as an educator extends to the medical students, physician assistants and nurse trainees who frequently rotate in the nursery and neonatal ICU; and

WHEREAS, Currently, Dr. Chhaya Patel's administrative responsibilities include presiding over the Credentials and the Pharmacy and Therapeutics Committees of the hospital; and

WHEREAS, With her throughout have been her husband, Mahendra, and their children, Prachee and Pratik, all of whom feel privileged to be a part of her life and rejoice in her achievements; and

WHEREAS, In the faithful performance of her duties and responsibilities, Dr. Chhaya Patel's ongoing efforts and notable
